Intends to apply part of the funds to cover eligible payments under the Contract for **execution of the works listed in the table below**. Bidding is open to all eligible Nepalese Bidders.
2. **Mithila Municipality, office of Municipal executive, Dhalkebar, Dhanusha** invites sealed bids from eligible bidders for the construction of works as per table below under National Competitive Bidding procedures. Only eligible bidders should participate in this bidding:
3. Eligible bidders may obtain further information and inspect the bidding documents at the office of **Mithila Municipality, office of Municipal executive, Dhalkebar, Dhanusha**
4. A complete set of bidding documents may be purchased from the office of the **Mithila Municipality, office of Municipal executive, Dhalkebar, Dhanusha** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Nrs. 3000/-** till **17:00 Hr (30th day from first day of notice published)**
5. Pre-bid meeting shall not be held.
6. Sealed bids must be submitted to the office **Mithila Municipality, office of Municipal executive, Dhalkebar, Dhanusha** by hand on or before **12:00 noon (31st day from first day of notice published)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 noon (31st day from first day of notice published)** at the office of **Mithila Municipality, office of Municipal executive, Dhalkebar, Dhanusha**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of as per table below which shall be valid for 30 days beyond the validity period of the bid.
