5. Electronic bids must be submitted through PPMO website system www.bolpatra.gov.np/egp on or before **12:00AM** on 2081/02/23 (5th jun 2024), Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM** on 2081/02/23 (5th jun 2024) at the office of **Mithila Municipality, Dhalkewar, Dhanusha**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs. 1,50,000.00** which shall be valid for 30 days beyond the validity period of the bid .
